38 COMMERCE DRIVE LLC 108-1-12 SITE PLAN

**Present:** Larry Torro, Engineer

Mr. Torro: This is 40,000 square foot warehouse situated on a little more than 3 acres on Commerce Drive. There were a few minor comments from the Village's engineer, Mr. Russo. One item that was outstanding was the approval from Orange County Sewer District, which we have obtained.

Chairwoman Escallier: I have to commend you with keeping up with the engineer's comments, updating everything that he's asked you to do.

Mr. Russo: I have a question regarding comment #2 under general comments. Do you know if the applicant's consultant will be working with the Village's attorney?

Mr. Torro: I know at one point Mr. Dowd had said that the applicant's attorney had contact with each other. They have made initial contact and know that they have to work together.

Mr. Russo: Ok, because the Mayor was wondering because the Village's attorney wasn't contacted. I wasn't sure if you were working with the Planning Board attorney or the Village's attorney.

Mr. Torro: I turned it over to the applicant's attorney who contacted the Planning Board attorney, Mr. Dowd. I can have the applicant follow up with him also.

Mr. Russo: That will also be a condition to the approval. As Mr. Torro noted, they did receive approval from Orange County Sewer District, that's all of the approvals that they needed from outside agencies. They already received approval from the Army Corp of Engineers for the wetland disturbance. We had some minor comments regarding construction details, one being added and another one corrected and we had some minor comments

regarding their Storm Water Pollution Prevention Plan. There were some references to wrong tables so that just needs to be cleaned up. Other than that, they have really brought the plans forwards and addressed everything that we've requested. This is still going to be Medex going in there?

Mr. Torro: As far as I know. I have no reason to think otherwise.

Chairwoman Escallier: I have nothing to add or ask. Do any of the Board members have anything that they would like to add or ask?

Member Kelly: I don't have anything to add, he has been very open about everything. I'm very happy.

There were no other comments from the Board members.

Chairwoman Escallier: Our attorney said that he would provide the corresponding resolution with the conditions and submit it for filing.
